3. Vehicle Specifications and explanation of additional services, equipment, and fees included in the overall total cost of the proposal.
4. Disclosure affidavit: Each bid shall be accompanied by a sworn and notarized DISCLOSURE AFFIDAVIT FOR COMPETITIVE BIDS for disclosure of Iran Linked and Familial Relationships. The

bid will not be accepted if the sworn and notarized affidavit are not included. DISCLOSURE AFFIDAVIT FOR COMPETITIVE BIDS needs to be included with bid.
